3. Eligibility/ Entitlement

- a. <u>Eligibility</u>. All Retd Offrs of AF less AFNS and Mjd Offrs are eligible provided the HP term in respective case expires max a day before **65th Birthday** of the Offre
- b. Ineligibility. Fol Retd Offrs will not be eligible to aval the facility:-
 - (1) Offrs Court-marshalled or Dismissed from svc on Disciplinary Gds.
 - (2) Offrs Retd prematurely on Inefficiency/ Disciplinary Gds.
 - (3) Offrs compulsory Retd due to fault.

- b. <u>Processing of HP App Forms</u>. App Forms complete in all respect shall be processed from a/m CSD Outlets and sent to HP Div at HO CSD through official mail or by hand under covering ltr.

5. To ensure smooth functioning of the Scheme, Offrs will be req to submit fol alongwith HP Application Form:--

- a. <u>Un dated Cheques</u>. In lieu of surety, customer will be required to provide undated, unnamed cheques of equal amount valuing HP Price of Car/Tractor for number of years equivalent to the HP term e.g, if HP value is Rs.2000,000/ issued for a period of Five Years then CSD will obtain 5x Cheques of Rs.400,000/- each and the same will be kept in safe custody of respective Case File.
- b. <u>Copy of Retirement Order</u> (Duly attested) shall be provided by the customer.

c. <u>SIDA Form</u> of Askari Bank and HBL Pension Acct shall be mandatory for Retd Offrs for CSD HP Scheme. Monthly instl shall be deducted from Pension Acct of the customer. Customer will render Undertaking that He/ She will not change His/ Her Pension Acct till complete realization / payment of CSD Hire Purchase monthly installments amount, Anx-A.

6. <u>Car Ins Policy</u> shall be mandatory for all customers and tracker shall be installed prior to delivery of veh to the customer. The cost of tracker shall be paid by the customer and shall be incl in DP. However subsequent tracker fee will be incl in instl plan. 7. <u>Monthly Instl</u>.
