**REQUIREMENTS FOR ARMS ISSUANCE**

1. HP application Form (Completed in all aspects) and duly signed by Customer and counter signed by Surety & CO.
2. ARI certificate (Dully signed / stamped by CO) mentioning that the Officer has already acquired one or no weapon before on said ARI and JCO has not acquired any weapon before on said ARI.

**SERVING AF**

Serving Army Person can purchase a Pistol against valid license AR(I)475, which states that the Arms Act does not apply to the bearing person or possession of Arms in duty. The following are Personal arms authorized to be borne or possessed by Officers and JCOs:-

**OFFICER.** Two Revolvers or two Pistols or one must take service ammunition of the authorized bore or caliber with a maximum of 100 rounds.

**JCOs and Eqvt.** One Revolver or one Pistol of Service Pattern as part of their equipment with a maximum of 100 rounds.

Keeping in view the above, a Certificate duly signed and stamped by his Commanding Unit/ Senior will be required to issue a Pistol.
